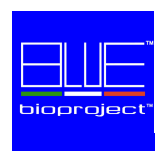




INFORMATION CIRCULAR

The *Blueitaly Group*<sup>TM</sup> is an Italian company that has been operating in the textile finishing industry for over 10 years. Offering unique know-how, the group manages projects and productions of special processes for the most important international fashion brands by investing in research, in the design of new solutions to innovate the fashion industry.

The company offers B2B services aimed at the transformation on fabrics provided by the customer and realization of finished product marketed from the model until the delivery of the complete garment.

The group manages the projects and the production of special processes by realizing the following techniques:

Hot laser, cold laser, mechanical and manual embroidery, needle punching, punching, ultrasonic, 3D printing, taping, heat sealing, laminating, blanking, embossed, screen printing, digital printing, sublimation printing.

The *Blueitaly Group*<sup>TM</sup> is present to Pescara with the business structures:

- *Blueitaly*<sup>TM</sup>Project, where representative, executive, administrative, design, acceptance and prototyping offices are present.
- *Blueitaly*<sup>TM</sup>Industry, registered office and production plant, storage and warehouse.

**ABC - Abruzzo Block Chain** is the digital certificate that contains information about the history of the product and the company, highlighting all the steps of production value. The information is validated through public Blockchain Technology giving the consumer maximum transparency.

The *Blueitaly Group*<sup>TM</sup> has encouraged the use of technologies to the benefit of its operators and disincentivando acts of transgression against human and environmental rights, is committed since its inception in achieving the objectives of corporate social responsibility.

With the desire to increase its commitment to achieving the strategic objectives of corporate sustainability for over 3 years, it has created a new division *Bioproject*<sup>TM</sup>.



The *Bioproject*<sup>TM</sup> division presents the brands *Industrial Waste*<sup>TM</sup> and *Chrisalys*<sup>TM</sup>, dedicated to the development of new textile coatings with zero environmental impact achieved through the use of materials obtained from the recycling of innovative resources and materials and materials possessing certifications.

To underpin the projects *Bioproject*<sup>TM</sup> there is the digital authentication ABC and the achievement of products made through processes certified GOTS.



**Gots - Global Organic Textile Standard** is the standard promoted by Textile Exchange that guarantees:

- The organic natural fibre content of both intermediate and finished products.
- Maintaining traceability throughout the entire production process.
- Restrictions on the use of chemicals and compliance with environmental and social criteria at all stages of the production chain, from the collection of natural fibres in the field to the subsequent manufacturing phases, up to the labelling of the finished product.

Textile products, manufacturing activities and chemicals for the textile industry can be certified according to GOTS.

The *Blueitaly Group*<sup>TM</sup> suggests to the customers that they intend to pursue the certification or that they intend to collaborate for the realization of a plan GOTS to undertake the following actions:

- Decide to undertake certification by contacting a certification body. For more information: <https://global-standard.org/>
- Decide to entrust the entire order to the group.

In this case, the *Blueitaly Group*<sup>TM</sup> in accordance with the requirements of the standard will have to commit from the purchase of the raw material to the achievement of the finished garment, ensuring the maintenance of traceability chain.

Please note that only companies that have undertaken the Global textile standard certification and renewed in the current year can be considered certified suppliers .

The GOTS protocol excludes any type of contamination, so a garment to be produced according to standards, must be made by plants within the certified supply chain from raw material to logistics. If this rule is not complied with, the certification will lapse.



Since 2022, the company is embarking on a path to GRS certification.

**GRS - Global Recycle Standar** is promoted by Textile Exchange and is the standard that recognizes the importance of recycling for the growth of a sustainable production and consumption model.

The standard guarantees:

- Products containing at least 20% pre-consumer and post-consumer recycling material;
- Manufacturing activities and processes through which recycled material is used to produce intermediate products (for example, yarns and fabrics) or finished products intended for the consumer, using models and management procedures that meet the requirements.

Today the GRS standard is mainly adopted in the acquisition of raw materials for the realization of textile finishing under the brand Industrial Waste somebody.

The *Industrial Waste*<sup>™</sup> proposals use pre-consumer recovery materials and materials that meet the requirements of the GRS certification system.

To companies that decide to continue in an *Industrial Waste* project, *Blueitaly group*<sup>™</sup> has suggested the following actions:

- Decide to use their surplus or waste materials collaborating with the design office to develop creative solutions for the realization of products.
- To entrust the Group to *Blueitaly Group*<sup>™</sup> the task of developing a *Waste Industrial*<sup>™</sup> project through the use of pre-consumer waste materials belonging to the Group.



**Chrysalis™** is the brand of the *Bioproject™* division at proposes new solutions of textile finishing for the valorization of innovative and sustainable raw materials.
